Looking Forward to the Year Ahead



I would like to begin by wishing all readers and members a healthy & prosperous New Year and I look forward to working with you throughout the year ahead. Within this newsletter a number of provisional 2020 dates and events are listed for you to note in your diary, and in the meantime,I would like to draw your attention to a few key matters IPAV will be addressing early in the year;

IPAV Conveyancing Survey 2020: As a follow up to our previous survey, we are keen to ascertain if members are seeing an improvement in conveyancing time frames or other improvements since the introduction of the Pre-Contract Investigation of Title (PCIT), as well as getting an overall update on conveyancing time frames and its effects on business. Please look out for this survey that will be emailed to all members early next week; your input is important to IPAV and the more responses received, the better the assessment.

IPAV Residential Property Price Barometer: Due for release at the end of this month, this will be IPAV's 6th report detailing the national and regional average property prices achieved by IPAV members. We look forward to the analysis and providing you with your own soft copy of the Q3 & Q4 2019 Barometer. As you are aware our barometer report attracts quite a lot of press coverage from the Sunday Independent on our barometer reports, so in conjunction with that, we have recently agreed a deal with all 46 regional papers to also give them the Barometer content and they will each feature the barometer in the week after the report is launched. Many of these papers will be in contact with members for commentary on the local market.

IPAV Digital Library: We have been working over the past year on a digital library exclusively for IPAV members that includes all IPAV reports, submissions, Government submissions, newsletters and property professionals over the past 7 years. This will enable members to access all IPAV's published documents from one central location on our website. We hope to have this project completed in the middle of the year, and will bring you further information in due course.

CPD: I will present the results of the 2019 CPD to TEGoVA on the 21st of January in Brussels. The new 2020 programme will be discussed including the informal 5 hours linked to our European Valuation Conference. Hopefully IPAV will be able to get the go ahead for this Pilot scheme again this year and we will be reporting after the meeting to all REV's and TRV's.

Taking place from 5.30pm Monday 13th January at the Midlands Park Hotel Portlaoise, we look forward to welcoming all members and guests to IPAV's first seminar of 2020. The IFA President Joe Healy will officially launch our 2019 Land Report at this event, together with IPAV's President David McDonnell and IPAV's Senior Vice President and Agri Committee Chairperson Tom Crosse will go through its findings. We also welcome guest speakers Gary Digney, Director at Accountants PFK-FPM to speak on Farm Debt and Jeremy Moody, CAAV Secretary and Advisor to speak on the after effects of Brexit on land prices and agriculture in the UK and Ireland. High Court confirms PSRA First Prohibition on a Licensee to Trade

On Monday, 25 November 2019, the President of the High Court Mr Peter Kelly permanently prohibited a former licensee, Mr Tony Breathnach who had traded as Cavan

Real Estate Ltd., Dublin Road, Cavan, from reapplying for a property service licence. This is the first occasion that a licensee or a former licensee has been "struck off" the Register of Licensees. Welcoming the Court's decision, the CEO of the Authority, Ms Maeve Hogan, said "The outcome in this successful High Court case highlights the Authority's zero tolerance approach to rogue licensees who put client funds at risk and also the important consumer protections contained in Property Services (Regulation) Act 2011." **Source:** PSRA. Proposal to Freeze Rent Unlikely to Become Law

A Sinn Féin Bill proposing a rent freeze has passed the second stage in the Dáil. The Rent Freeze (Fair Rent) Bill, 2019 was brought forward by Sinn Féin's housing spokesperson Eoin Ó Broin and supported by Fianna Fail to allow it to progress to Committee Stage for further scrutiny. However, Fine Gael opposed the Bill on the grounds that it is unconstitutional. As a result, it is likely to languish in limbo for the foreseeable future.
