BUILDING YOUR CAREER WITH IPAV

The Institute of Professional Auctioneers & Valuers (IPAV) is a professional representative body for auctioneers, valuers and estate agents nationwide. The Higher Certificate in Business in Real Estate (Valuation, Sale and Management) is a level 6 award (120 ECTS) developed in collaboration with TU Dublin and is approved by the Property Services Regulatory Authority for licensing purposes. It is a challenging two year course that covers issues relating to the valuation, sale and letting of residential property.

It is designed to meet the requirements of a changing and demanding market where the property professional will be expected to perform to the most exacting standards.

Once you have successfully completed the 2 year Higher Certificate course you will have the advantage of an academic qualification; have laid the foundation for further study; be eligible to apply for a PSP licence (categories A,B,C and D) and also eligible to apply for membership of the Institute of Professional Auctioneers and Valuers; and you will also gain immense personal satisfaction from the achievement.

COURSE OVERVIEW

The programme is designed to meet the needs of those already working in the industry or related areas who wish to obtain a formal educational qualification. It is also suited to those who wish to enter the profession for the first time and who wish to satisfy the requirements of the Property Services Regulatory Authority. In this instance the Higher Certificate in Business in Real Estate (Valuation, Sale and Management) meets the requirements of the PSRA for licensing purposes.

YOUR COMMITMENT

Since the Higher Certificate in Business in Real Estate (Valuation, Sale and Management) is an academic qualification you are expected to give time to study and reading, in addition to attending lectures. The course demands a critical and logical approach to tasks, rather than mere description and therefore, students are expected to be independent in their approach to study and to read widely around the set text. Weekly time devoted to private study has to be managed effectively so that you can meet deadlines.

COURSE DELIVERY

The course will be delivered on Saturdays over two consecutive academic years. The year is divided into two semesters, commencing September – December and January – May each year.

In addition to formal face to face lectures, students will also receive tuition online. Students will be expected to do home study as directed and prepare assignments for submission on specified dates.

Students will also be expected to demonstrate learning through work and for that reason those who are not already employed in the profession are expected to obtain work experience or agree some degree of work shadowing in order to complete the Professional Practice module.

The Professional Practice Module is mandatory and must be completed by all students to obtain a level six qualification.

TU Dublin uses an online learning platform where course information – coursework assignments, timetables, notes, etc. can be downloaded.

The venue for the course will be the Technological University Dublin – Tallaght Campus, Dublin, D24 FKT9

EXAMINATION & ASSESSMENT

Students will be assessed by examination and coursework. The latter will take different forms – short essays, reading/comprehension, role play and presentation, as directed by each lecturer.

Examinations will be of two hours duration, with a repeat facility in the Autumn. Students are required to pass all elements of the assessment to progress through the stages of the award. Examinations will be held after each semester, January and May.

COURSE FEE

Each student is required to pay the course fee of €3,500 per annum, which includes registration, tuition, examination entry, student notes and access to all the learning resources available in TU Dublin for students.

ENTRY REQUIREMENT

Applicants should have achieved a minimum of at least grade O6 or H7 in 5 subjects. The subjects must include Maths and either English or Irish. The level of English required if English is not the applicants first language is IELTS 6.0 or equivalent.

Applicants who do not meet the minimum standard of education, as required above will be assessed on previous qualifications and work experience.

Applicants who have achieved learning outside the formal education or training systems may also apply for the course and their application will be assessed under the Accredited Prior Experiential Learning process.
