Quarterly Update from First Home Scheme


The First Home Scheme recently provided the market with its Q1 2024 update, which shows a considerable uplift in scheme usage during the quarter, with a 118% increase in the number of new homes (sales closed) purchased using the scheme (262 homes in Q1 2024, versus 120 in the same quarter last year).

To-date over 4,000 First Time Buyers have been approved by the scheme and have received eligibility certificates' allowing them to buy or self-build their first home.

Price Ceilings are currently being reviewed with the outcome of this review to be announced in early July.

Energy Performance of Buildings Directive (EPBD) - Update



Following details in our April newsletter, The Council of the European Union formally adopted the revised EPBD on April 12, 2024. All new buildings must be zero-emission by 2030, with public buildings required to comply by 2028. Member States are now required to establish a national trajectory for progressively renovating their residential building stock to transform it into a zero-emission building stock by 2050.
